

Members Contribution Rules

Article 1 Basic Principle

These Subscription Regulations are not an integral part of the Statutes. They govern members' obligations to pay subscriptions, as well as other charges and apportioned costs. The Subscription Regulations are adopted by the Executive Board.

Article 2 Resolutions

If necessary, these Subscription Regulations may be amended by resolution of the Executive Board. The adoption of resolutions shall be governed by the provisions of the internal rules of procedure of the Executive Board. The Executive Board shall announce the currently valid version of the Subscription Regulations in the form of a circular to members.

Article 3 Subscriptions

Pursuant to Article 5 of the Statutes, the Executive Board adopts the following Subscription Regulations for levying subscriptions to *Mobility goes Additive* e.V.:

(1) The subscriptions are an annual subscription. The first subscription year shall be the financial year stipulated in the Statutes; the subscription year shall thereafter be from 1 July to 30 June of the calendar year.

(2) The subscription level shall be based on the size of the member's business enterprise and is graded as follows:

Membership structure (based on the number of employees)	Annual subscription	One-off admission fee
Small enterprise (up to 250 employees)	€ 2500.00	€ 1250.00
Medium-sized enterprise (>250 & <2000 employees)	€ 7000.00	€ 3500.00
Large enterprise (>2000 employees)	€ 14,000.00	€ 7000.00
Universities	€ 1000.00	€ 500.00
Institutes, associations, local authorities	€ 3000.00	€ 1500.00
Other	€ 2000.00	€ 1000.00

(3) Payment dates and terms

(3.1) Subscriptions for the current financial year are payable by 15 July of each year. In the year of admission, the subscription is payable at the time of admission.

(3.2) Subscriptions are payable 14 days after receipt of invoice.

(3.3) When new members are admitted, it should be agreed wherever possible that subscriptions are payable in the form of direct debit. Exceptions to this procedure can be agreed in legitimate individual cases.

(3.4) Resignation from Mobility goes Additive e.V. shall not affect the member's obligation to pay subscriptions. No refunds will be granted for subscriptions which have already been paid.

(4) Enforcement of claims

(4.1) The Executive Board or the office of Mobility goes Additive e.V are instructed to send a reminder demanding payment of outstanding subscriptions on 31 December of each financial year and to take all necessary legal action thereafter to collect the subscriptions.

(4.2) All legal disputes concerning claims of Mobility goes Additive e.V against its members for the payment of subscriptions shall be resolved before the local court at the registered office of Mobility goes Additive e.V.

(5) In legitimate individual cases, the Executive Board is entitled to decide on a reduction, waiver or deferral of subscriptions on application by the member.

Article 4 Charges

Separate charges, expenses, reimbursement of costs etc. may be levied for additional offers (seminars, symposia etc.). These shall be individually resolved by the Executive Board.
